## Early Warning System (EWS) for Imported Food & Feed, January 2024

**Summary:** Recent results based on the analysis of EU RASFF (Rapid Alert System for Food and Feed) notifications for imports of food and feed both from outside and inside the EU; other international intelligence gathered via the FSA's Signal Prioritisation dashboard; and since January 2021 UK Border Notifications (BNs) issued when unsatisfactory imports are rejected at UK ports or found inland. Awareness of these findings can assist enforcement officers and others' sampling programmes.

Please bring this letter to the attention of all relevant officers in your authority and/or other interested parties if appropriate. The EWS priority ranking (high/medium/lower) is based on the level of health risk in the product, the extent of risk to the population as a whole based on consumption, and extent of benefits of sampling. **\*Commodities of special interest this month are highlighted\***

Issue: Food Safety News article reporting that the Food Standards Agency (FSA) is inviting public comments on a proposal that limits ethylene oxide in food additives. The consultation also includes four novel food and three food additive applications submitted for authorization and plans to remove the approval for 22 food flavourings. Responses are required by March 25. A similar consultation has been opened by Food Standards Scotland, which closes on March 29.
